1. Introduction

3. The Information We Collect

a) Information you provide directly

- Your name, company name, and job title
- Contact details (email address, telephone number, postal address)
- Enquiry details or service requests
- Billing and payment information
- Job applications or CVs if you apply to work with us

b) Information collected automatically

- IP address and browser type
- Device information and operating system
- Pages visited, time on site, and referring websites
- Cookies and analytics data (see our Cookie Policy)

c) Information received from third parties

- Business partners and subcontractors
- Credit reference agencies (for trade accounts)
- Publicly available sources such as Companies House

4. How We Use Your Personal Data

We process your personal data to:

Respond to your enquiries and provide quotations

- Supply goods and services (engineering or plant hire)
- Manage our relationship with you, including invoicing and payments
- Notify you of changes to our services or policies
- Comply with legal and regulatory obligations
- Improve our website and customer experience
- Process job applications

We will not use your personal data for any purpose incompatible with the above.

5. Lawful Basis for Processing

Under data protection law, we must have a lawful reason ("lawful basis") to process your data. The lawful bases we rely on are:

- **Contract** to perform a contract with you or take steps at your request before entering a contract.
- Legal obligation to comply with our legal duties (e.g., record keeping, tax obligations).
- **Legitimate interests** for our legitimate business interests (e.g., responding to enquiries, improving services) where your rights are not overridden.
- Consent where you have explicitly consented, such as for marketing communications.

6. Sharing Your Personal Data

We may share your personal data with trusted third parties such as:

- Service providers and subcontractors assisting with our engineering or hire services
- Professional advisers (accountants, solicitors, insurers)
- IT and website hosting providers
- Payment processors and banks
- Government bodies or regulators when required by law

All third parties are required to handle your data securely and use it only in accordance with our instructions and the law. We do **not** sell, rent, or trade your personal data to any third parties for marketing purposes.

7. Data Retention

We retain personal data only for as long as necessary to fulfil the purposes we collected it for, including legal, accounting, or reporting requirements.

- Customer and supplier records: **6 years** after the last transaction
- Financial records: **6 years** (HMRC compliance)

- Job applications (unsuccessful): up to 12 months
- Marketing consents: until withdrawn

After this period, your data will be securely deleted or anonymised.

8. Your Data Protection Rights

Under the UK GDPR, you have the following rights:

- Access request copies of your personal data
- Rectification request correction of inaccurate data
- **Erasure** request deletion of your data
- **Restriction** limit the use of your data in certain circumstances
- **Portability** request transfer of your data to another organisation
- Objection object to processing based on legitimate interests or marketing
- Withdraw consent withdraw consent where applicable
